

Christmas in Clinton – Holiday Shopping Passport OFFICIAL RULES

No purchase necessary to enter or win. Making a purchase or payment of any kind will not increase your chances of winning. Void where prohibited or restricted by law.

1. **PROMOTION DESCRIPTION:** The Christmas in Clinton Holiday Shopping Passport ("Sweepstakes") begins on October 21, 2017 at 12:01 am and ends on December 3, 2017 at 3:00 pm (the "Promotion Period").

The sponsor of this Sweepstakes is the Clinton Chamber of Commerce Inc. ("Sponsor"). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection and processing of Entries and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes. 2. **ELIGIBILITY:** Open to legal residents of the United States over the age of 18 (the "Entrant"). Entries submitted by mail must arrive prior to drawing date. Entries may be submitted in person until 3:00 pm on December 3, 2017.

Only one entry per person; any attempt by Entrant to obtain additional Entries by using multiple/different addresses, identities, or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void Entrant's Entries and that Entrant may be disqualified. Final eligibility for the award of any prize is subject to verification of identity.

The random drawing will be conducted at or about 4:00 pm on December 3, 2017 at the Andrews Memorial Town Hall, Clinton CT, by Sponsor or its designated representatives, whose decisions are final.
